Cookie Policy

Our website, <https://pmcveybuildingsystems.com> ("the website"), uses cookies and other related technologies (collectively referred to as "cookies"). Cookies may also be placed by third parties that we engage with. This document explains what cookies are, how we use them, and your options regarding their use.

- A cookie - Is a small file that is sent along with pages of this website and stored by your browser on your device. Information stored in these cookies may be returned to our servers or to the servers of relevant third parties during subsequent visits.
- A script - Is a piece of programming code used to ensure our website functions correctly and interactively. This code runs either on our server or on your device.
- A web beacon (or pixel tag) - Is a small, invisible piece of text or image on a website used to monitor traffic. Information such as your device or browsing behaviour may be stored using web beacons.

Cookies

5.1 Technical or functional cookies

These cookies ensure parts of the website function properly and allow us to remember your preferences. They help improve your experience by preventing you from repeatedly entering the same information. Functional cookies may be placed without your consent.

5.2 Statistics cookies

Statistics cookies help us understand how visitors use our website so we can optimise performance and user experience. We will ask for your permission before placing these cookies.

5.3 Marketing / Tracking cookies

These cookies are used to create user profiles or to track your activity across this website and other websites for marketing and advertising purposes.

5.4 Social media cookies

We may embed content from LinkedIn or Instagram. These platforms may use cookies that collect data for personalised advertising and analytics when such content is viewed or interacted with.

Placed Cookies

We use cookies on our website for several purposes. These cookies fall into the following categories:

6.1 Functional cookies

These cookies ensure the website operates correctly and remembers your preferences. They may be placed without your consent.

6.2 Statistics cookies

These cookies help us understand how visitors use the website so we can improve functionality and performance. We request your consent before using these cookies.

6.3 Marketing/Tracking cookies

These cookies are used to create user profiles and display relevant advertisements. They may also track your activity across different websites. We request your consent before using these cookies.

6.4 Social media cookies

When we embed content from social media platforms (such as LinkedIn or Instagram), these platforms may place cookies for analytics, personalisation, or advertising.

Detailed descriptions can be provided if required.

Consent

When you visit our website for the first time, we show a cookie consent pop-up explaining our use of cookies. Once you click "Save settings", you consent to the categories of cookies you selected. You may disable cookies in your browser at any time; however, some website functionality may be affected.

7.1 Manage your consent settings

If cookies are loaded without JavaScript support (e.g., on AMP pages), you may need to use the consent management options at the bottom of the page.

Enabling, disabling, and deleting cookies

- You can use your internet browser to automatically or manually delete cookies. You can also specify that certain cookies may not be placed.
- You may configure your browser to notify you whenever a cookie is placed. Guidance on this can be found in your browser's Help section.
- Please note - If all cookies are disabled, some parts of our website may not function correctly. Deleted cookies may be placed again after you give consent when revisiting our website.

Your rights with respect to personal data

You have the right to:

- Know why your personal data is needed, how it is used, and how long it is stored.
- Access your personal data.
- Rectify or supplement inaccurate personal data.
- Withdraw consent and request deletion of your personal data.
- Transfer your personal data to another controller.
- Object to the processing of your personal data, unless required by law or justified by legitimate grounds.
