## **Data and Privacy Policy**

This privacy policy will explain how P McVey Building Systems Ltd uses the personal data we collect from you.

### **What data do we collect?**

- Personal identification information (Name, email address, phone number, etc.)
- Bank Details
- National Insurance and UTR numbers (This list is not exhaustive).

### **How do we collect your data?**

You directly provide P McVey Building Systems Ltd with most of the data we collect. We collect data and process data when you:

- Use or view our website via your browser's cookies.
- Reply to advertising via telephone call, whatsapp, email or text message.

### **How will we use your data?**

### **How do we store your data?**

Once this time period has expired, we will delete your data by shredding and disposing of forms and all other data held about you including contact details held digitally. All digitally held data is password protected and all backups are encrypted. All computer equipment is secured with firewalls, virus scanning programs, all laptops and desktop computers are password protected.

If you have agreed to receive marketing, you may always opt out at a later date. You have the right at any time to stop P McVey Building Systems Ltd from contacting you for marketing purposes.


## **What are your data protection rights?**

- **The right to access** – You have the right to request P McVey Building Systems Ltd for copies of your personal data.
- **The right to rectification** – You have the right to request that P McVey Building Systems Ltd correct any information you believe is inaccurate. You also have the right to request P McVey Building Systems Ltd to complete the information you believe is incomplete.
- **The right to erasure** – You have the right to request that P McVey Building Systems Ltd erase your personal data, under certain conditions.
- **The right to restrict processing** – You have the right to request that P McVey Building Systems Ltd restrict the processing of your personal data, under certain conditions.
- **The right to object to processing** – You have the right to object to P McVey Building Systems Ltd processing of your personal data, under certain conditions. The right to data portability you have the right to request that P McVey Building Systems Ltd transfer the data that we have collected to another organisation, or directly to you, under certain conditions.
